Subject: Waste Containers and Recycling Program

Date: February 24, 2014

The Airport provides several designated waste container locations for use by Airport, Airlines, Tenants, and Concessionaires personnel. Each location has containers clearly marked for regular waste and recyclables. Regular waste containers are suitable for routine, non-recyclable trash (e.g. food, office materials). Recyclable waste containers are designated for specific materials (e.g. cardboard, mixed- recyclables). The mixed-recyclable waste containers may be used for paper, glass, plastics, and metals. Descriptions, locations, and informational postings are included with this document and should be distributed/posted for wider audience awareness. NOTE: Those areas depicted on page 2 are more common areas. There are other multiple waste containers around the Airport and waste or recyclables should be disposed of according to the container markings.


Please note that when routine waste materials are mixed with recyclables, the waste vendor considers the entire container compromised and redirects to the landfill. Little, if anything in the container is recycled. The following guidelines support the Airport community's effort towards successful recycling:

- Single Stream Recycling (SSR) containers cannot have mixed trash.
- All cardboard must be broken down before being placed in containers.
- Compactors should be used first and then dumpsters.
- No trash should be left outside the containers.
- Bottles should not be broken in the containers.
- Doors and lids must be closed at all times to prevent FOD (foreign object debris) and aircraft damage.
- Report any overfill or issues to the Airport ACC @ 7777.

Please share the need for proper disposal among all staff through briefings and postings or contact your KCAB representative if additional information is needed.

Start recycling today! Rumpke Recycling offers a convenient curbside recycling program, which accepts a wide variety of materials.

Acceptable items include:

- · All plastic bottles, no lids
- · Glass jars and bottles of any color
- . Aluminum, steel and empty aerosol cans with lids and tips removed
- . Paper bags, envelopes with or without windows, junk mail, computer paper and other mixed office paper, magazines, telephone books and newspapers with inserts
- · Paperboard, such as cereal boxes
- . Corrugated cardboard, broken down to 3' x 3'
- · Pizza boxes with all grease and food residue removed



Unacceptable items include:

- · Plastics that are not bottles, such as Cool Whip containers, butter tubs, or food trays
- · Plastic bags
- Styrofoam
- Lids/caps
- . Window or drinking glass and light bulbs
- . Coat hangers or steel scrap
- · Motor oil jugs, paint cans, or other chemical containers
